AMENDED NOTIFICATION

Jaipur, 6th September, 2007

In exercise of the powers conferred by section 15 of the Mines & Minerals (Development and Regulation) Act, 1957 (Central Act No. 67 of 1957), the State Government issued Notification dated 25th August, 2007, published in Rajasthan Extraordinary Rajpatra on dated 30.8.2007 is hereby further amended as under :-

1. Short title and commencement :- (1) These rules may be called the Rajasthan Minor Mineral Concession (Amendment) Rules, 2007.
- (2) They shall come into force from the date of publication of Notification in Rajasthan Extraordinary Rajpatra.
2. Amendment of Schedule I.- Schedule-I appended to the Rajasthan Minor Mineral Concession Rules, 1986 shall be substituted by the following, namely :-
